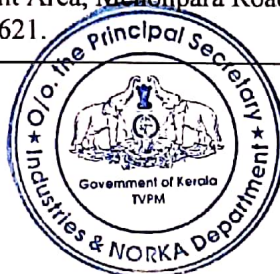

Dear District Collectors,

Sub: Covid-19 –Exemptions for essential industries

It is hereby clarified that, the following industrial houses/units come under the purview of the guidelines issued by Government of India vide, Ministry of Home Affairs Order No. 40-3/2020-D dated 24.03.2020 and G.O. (Ms) No. 13/2020/DMD dated 26/03/2020 by the Department of Disaster Management, Government of Kerala and subsequent clarifications issued by Ministry of Home Affairs, Government of India. These units are therefore, exempted from the lock down and allowed to function with the conditions stipulated below:



2. You are therefore, directed to facilitate these units to function smoothly during the lock down period considering their role in the maintenance of supply of essential items. They shall abide by the following conditions:

- (i) Social distancing norms shall be strictly followed by all in the unit.
- (ii) Proper sanitization shall be maintained in the premises of the unit.
- (iii) Adequate hand sanitizers and hand washing facilities shall be made available for the workers.
- (iv) The body temperatures of the workers shall be checked and satisfy that, no one is suffering from fever, cough or restlessness.
- (v) Congregation of more than 5 persons in a spot to be prevented.
- (vi) The functioning of the plant /unit shall be video recorded or a CCTV camera installed and recorded for verification of the observance of these conditions.

3. You are also requested to report any violation of these conditions, for cancellation of the permission granted herewith.
