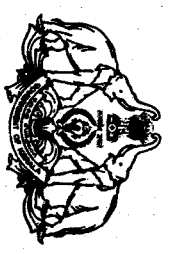

S. R. O. No. 651/2018.—In exercise of the powers conferred by sub-sections (1), (2), (2A), (6) and (7) of Section 8 and Section 10 of the Factories Act, 1948 (Central Act 63 of 1948) and in supersession of the notification issued under G.O. (Rt.) No. 1144/2005/LBR, dated 2nd May, 2005 and published as S.R.O. No. 428/2005 in the Kerala Gazette Extraordinary No. 936 dated 3rd May, 2005 the Government hereby:—

- (1) appoint each of the officers in the Department of Factories and Boilers mentioned in column (2) of the Schedules hereunder to be the Inspectors and Additional Inspectors to assist the Chief Inspector, as the case may be, as shown against each such officer in column (3) thereof;
- (2) assign each of them the local limits as shown against each of them in column (4) of the said Schedules (annexure) within which they shall exercise their powers;
- (3) specify, against each of them in column (5) of the said Schedules, the authority in which each of them shall be officially subordinate;
- (4) declare each of the officers specified in column (6) of the said Schedules to be the authority to whom the prescribed notices and returns in respect of the factories situated in the areas specified against each of them in column (4) of the said Schedules shall be sent; and
- (5) declare that the said officers shall exercise the powers conferred on the Inspectors under the said Act within the local limits specified in Column (4) of the said Schedule subject to the following conditions, namely:—
 - (i) Prosecution shall be filed only with the prior sanction of the sanctioning authority.
 - (ii) The power to sanction prosecution against factories coming under section 2(m) of the Factories Act, 1948 and power to suspend the operation of an order issued by an Inspector or other officer shall be exercised by the Chief Inspector.
 - (iii) The Deputy Chief Inspectors shall be the controlling officers for the Inspector of Factories and Boilers Grade I, Grade II, Chemical Inspectors and Medical Officers appointed within their respective jurisdiction.
 - (iv) The Joint Director of Factories and Boilers (Medical) shall be the controlling officer for the Technical Officer (Chemical), Technical Assistant/Chemical Inspector appointed in the Industrial Hygiene Laboratory and the technical control and supervision of the Medical Officers appointed within his jurisdiction.

- (v) The Deputy Chief Inspectors shall exercise the following powers of the Chief Inspector within their respective jurisdiction:
 - (a) Dispose of applications for approval of plan and issue permit, revalidation of permit, in respect of factories employing up to 20 workers under rule 3 of the Kerala Factories Rules, 1957.
 - (b) Dispose of applications for amendment of licence under rule 6 of the Kerala Factories Rules, 1957.
 - (c) Dispose of applications for renewal of licence under rule 7 of Kerala Factories Rules, 1957.
 - (d) Dispose of applications for transfer of licence under rule 8 of Kerala Factories Rules, 1957.
 - (e) Dispose of applications for registration and grant licence in the category of factories notified under sub-section (1) of section 85 of the Factories Act, 1948.
 - (f) Dispose of prosecution proposals in respect of factories coming under the category of factories notified under sub-section (1) of section 85 of the Factories Act, 1948.
 - (g) Dispose of applications for approval of plans of buildings to be constructed, reconstructed or extended, for a factory and for the issue of permission specified under rule 3 of the Kerala Factories Rules, 1957 in respect of all factories within the purview of Special Economic Zones irrespective of number of workers employed therein.
- (vi) The Inspector of Factories and Boilers Grade I shall exercise the powers of Inspector in respect of all factories situated within the factory division where he is appointed. He shall be the Controlling Officer of all the Inspectors of Factories and Boilers Grade II of the respective sub regions under his jurisdiction and the Additional Inspector of Factories within the factory division.
- (vii) The Inspector of Factories and Boilers Grade II shall exercise the powers of Inspector in respect of all factories situated within the factory divisions where he is appointed. He shall be the controlling officer of the Additional Inspectors of Factories of the division under his jurisdiction.

- (viii) The Additional Inspector of Factories shall exercise the powers of Inspector in respect of non-hazardous factories coming under the category of factories notified under sub-section (1) of section 85 of the Factories Act, 1948 situated within the respective jurisdiction.
- (ix) The Joint Director of Factories and Boilers (Medical) shall exercise the powers of Certifying Surgeon under section 10 of the Factories Act, 1948 and also advise the Director of Factories and Boilers, Joint Director of Factories and Boilers, Inspector of Factories and Boilers as the case may be, and shall exercise supervision of the Medical Officers of the Department.
- (x) The Officer designated as Medical Officers shall exercise the powers of Certifying Surgeon under section 10 of the Factories Act, 1948 within their respective jurisdiction.
- (xi) The Inspector of Factories and Boilers Grade II in the Full Safety Control System Cell attached to the office of the Joint Directors of Factories and Boilers shall exercise the powers of Inspector under sub-section (2B) of section 8 of the Factories Act, 1948 within their respective jurisdiction.
- (xii) Technical Officer (Chemical) and Chemical Inspector/ Technical Assistant (Chemical) shall exercise the powers of Inspector under the provisions of sub-section (2B) of section 8 of the Factories Act, 1948 for serving the purpose of "Full Safety Control System Cell" constituted as per G.O. (Rt.) No. 269/87/LBR, dated 9th February, 1987. Technical Officer (Chemical) will have the technical control of the Technical Assistant (Chemical)/Chemical inspectors working in the Industrial Hygiene Laboratory. They shall be the Specialist Inspectors for advising the Chief Inspector or Deputy Chief Inspector as the case may be, on matters involving Chemical Safety within the local limits assigned to them.
