In exercise of the powers conferred by section 112 of the Factories Act, 1948 (Central Act 63 of 1948), the Government of Kerala, after having previously published the draft rules calling for objections and suggestions, issued as per the notification No.B2/188/2024/LBR dated 16th October, 2024 published in the Kerala Gazette Extraordinary No.3299 dated 19th October, 2024 as required under section 115 of the said Act and having not received any objections or suggestions thereon,



hereby make the following rules further to amend the Kerala Factories Rules, 1957, namely:-

RULES

- 1. Short title and commencement.— (1) These rules may be called the Kerala Factories (Amendment) Rules, 2025.
 - (2) They shall come into force at once.
 - 2. Amendment of the Rules.- In the Kerala Factories Rules, 1957,-
 - (i) For APPENDIX I, the following APPENDIX shall be substituted, namely:-

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The fee for registration and grant of licence for factories and renewal of licence prescribed in the Kerala Factories Rules, 1957 were last revised by the Government as per notification issued



vide G.O.(P) No.72/2022/LBR dated 13th July, 2022 and published as S.R.O No.722/2022 in the Kerala Gazette Extraordinary No. 2408 dated 20th July, 2022. Since then, there has been a tremendous increase in the expenditure of the Department of Factories and Boilers, which is administering the Factories Act, 1948 (Central Act 63 of 1948) and providing the necessary services to the factories. Moreover, as per G.O.(P) No.55/2024/Fin. dated 17th July, 2024, rate of user charges and fees for the services provided by all Government Departments were revised by Government to meet the increased expenditure. Hence, the Government have decided to make suitable amendments in the Kerala Factories Rules, 1957.

The notification is intended to achieve the above object.
