In exercise of the powers conferred by subsections (1) and (2A) of section 8 and section 10 of the Factories Act, 1948 (Central Act 63 of 1948) and sub-sections (1), (2) and (4) of section 5 of the Indian Boilers Act, 1923 (Central Act 5 of 1923) and in supersession of the notification issued under G.O.(P) No. 97/2021/LBR dated 16<sup>th</sup> December, 2021 and published as S.R.O. No. 990/2021 in the Kerala Gazette Extraordinary No. 3802 dated 24<sup>th</sup> December, 2021, the Government of Kerala hereby appoint each of the officers in the Department of Factories and Boilers, mentioned in

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government have appointed officers in the Department of Factories and Boilers to perform duties and responsibilities envisaged under various provisions of the statutes such as the Factories Act, 1948, the Indian Boilers Act, 1923. Some newly recruited officers have joined duty in the Department. In order to enable them to discharge their statutory functions, these officers need to be notified in the official gazette specifying the capacity in which they are appointed.

The notification is intended to achieve the above object.
